As per the Resolution Plan, the <b>post-resolution shareholding</b> comprises <b>95% held by the Promoter Group</b> and <b>5% held by the Public</b>.  In this regard, the Company has submitted an <b>in-principle approval application to BSE</b>, which is currently <b>under review</b>. The <b>corporate action</b> necessary to implement the revised shareholding structure is <b>in progress</b>. Consequently, the Company's <b>ISIN has been temporarily suspended</b>, and <b>all related activities, including trading of equity shares, have been suspended since the end of December 2024</b>.  Due to the suspension of the ISIN by the depositories in light of the ongoing corporate action, the <b>Registrar and Transfer Agent (RTA)</b> does not have access to updated equity shareholding data for the <b>quarter ended December 30, 2025</b>.   Therefore, for the purpose of filing this certificate, the <b>equity shareholding details (both in dematerialized and physical form)</b> have been taken as per the data available as of <b>March 31, 2025</b>, based on the information provided by the Registrar of the Company.</p>
